RAPESEED

Transactions in rapeseed

Effective from 1. January 2025

Where the supplementary provisions deviate from the provisions of the Copenhagen Contract, the following supplementary provisions shall apply.

1 ANALYSIS WARRANTIES

Oil content: Basis 40%, analysis according to petroleum ether or N.M.R.-method.

Impurities: Basis 2% maximum 4%.

Moisture: Basis 9% maximum 10%.

Erucic acid: Maximum 2% calculated on the basis of the total fatty acid content of the oil.

Glucosinolates: Maximum 25 micromol/gram.

FFA: Maximum 2%.

Heat-damaged seeds: Maximum 5% according to Canadian standard strip test.

2 SAMPLING

The Buyer shall request drawing and sealing (with wax or lead) of analysis samples (for oil content, impurities and moisture), and sampling etc. shall take place in accordance with the relevant provisions of the Contract. Samples drawn for testing of oil content and moisture shall be filled into clean, air-tight bottles, plastic bags or other suitable containers.

With respect to lots weighing more than 500 tonnes, samples may be sealed for each commenced 500 tonnes if so demanded by either party.

3 ANALYSES

All analyses shall be made on a tel quel basis, and according to FOSFA-approved methods (heat-damaged seeds excepted).

Analysing: Buyer shall effect first analysis for oil content, impurities and moisture.

Places of analysis: First analysis: A recognized Danish laboratory.

Second analysis: Other recognized laboratory.

Costs of analysis:

Costs of analysis for first analysis for oil content, impurities and moisture shall be divided equally between buyer and seller. At any second analysis for the above warranties,

costs shall be defrayed by the party requesting it.

4 ANALYSIS ALLOWANCES

Oil content: 1.25% reciprocally for each 1%.

Impurities: Up to 2%: allowance of 1% for each 1% to seller.

Over 2% up to 3%: allowance of 1% for each 1% to buyer.

Over 3% up to 4%: allowance of 2% for each 1% to buyer.

Over 4%: buyer is entitled to reject.

Moisture: From 6% to 7.5%: allowance of 0.5% for each 1% to seller.

Over 7.5% up to 9%: allowance 1% for each 1% to seller.

Over 9% up to 10%: allowance 1% for each 1% to buyer.

Over 10%: buyer is entitled to reject.

For all analysis allowances, fractions shall be settled in proportion.
